





Services

Resource recycling of OA, electronic and electrical equipment

We recycle composite waste such as computers by manually disassembling and sorting it to increase its value as a material.

Thorough manual work contributes to improving the recycling rate and reducing environmental impact.

• Resource recycling of printed circuit boards, electronic parts, etc.

We are collaborating with refining manufacturers to establish a resource recovery flow and recover rare metals such as gold, silver, copper, and palladium.

We handle a wide range of products, from products with low copper content such as board scraps to products with high precious metal content such as communication boards typified by mobile phones.

Recycling of packaging, mixed waste, etc.

We collect packaged and mixed waste such as unnecessary parts and semi-finished products that are disposed of from factories.

We provide comprehensive support from unpacking to sorting, disassembly, and shredding.

Data destruction service

Data remaining on computers, magnetic tapes, etc. will be physically or magnetically destroyed using a dedicated data destruction device or crusher, making the data unrecoverable.

We also support on-site data destruction work at designated locations.

Collection and transportation with own vehicles

As a general rule, we give priority to our own vehicles for collecting the scrap we receive, and in addition to improving our services, we also install and rent out containers to propose safer and more efficient storage and collection.

Nationwide collection and recycling service

We can handle everything from collection and transportation to disposal of unnecessary products and equipment that are discarded from stores and offices throughout Japan. We provide services tailored to customer needs regarding removal conditions, processing methods, etc. at minimum cost.

We accept a wide variety of items, from the disposal of waste plastic to the purchase of precious metals. In addition to the above, we are also able to provide other processing and services in accordance with customer requests.













Products

Printed circuit boards

Desktop PC , notebook PC , hard disk , memory, server, control, power supply, etc.





Electronic components

IC, connector, capacitor, resistor, terminal, contact, transistor, LED, etc.

Electronics

Solder (lead-free and leaded), silicon wafers, various target materials, carbide tools, secondary batteries, other rare metals, and composite materials containing them.

Our company has obtained a collection and transportation license in 45 prefectures nationwide (excluding Hokkaido and Okinawa prefectures) and collects and transports a variety of industrial waste discharged from production factories, office buildings, etc.

The industrial waste collected by our company is transported to five locations nationwide (Fukushima, Kanagawa, Gifu, Hyogo, and Fukuoka prefectures) that have obtained permission to disposal of industrial waste.

Also We dispose of waste appropriately using methods designed to reduce the amount of waste in accordance with relevant laws and regulations for the environmental impact is reduced.
